## Privacy policy

When you visit our website (webpage ecoearthcoin.com and its subpages, “**Site**”) or we have any communication or interaction with you, your personal data is collected and processed by ECONEUARK platform from Project First Eco-Cluster (an Estonian private limited company, registry address Peterburi tee 47, Tallinn, Estonia “First Eco-Cluster” OÜ (14598886) or “we”). This Privacy Policy explains how we process your personal data. We collect only what we need and will not share your personal data with any third parties other than our identity verification partner. We process all data within the European Union and comply with applicable European Union and national laws on personal data protection and privacy. If you do not agree with our practices, please do not use our Site and the services offered therein (“**Services**”).

### Types of Information We Process:

**Personal Data:** We collect personal data you provide to us when you sign up to our pre- sale mailing list and/or create an account. The personal data we process may consist of: your full name, username, email address, your address, country of residence, age, any other information on your identity document, credit card and bank information (without the CVV code), details of any requests or transactions you make through the Services, and communications you send to us or submit to the Site (“**Personal Data**”);

**Aggregate and Anonymous Data:** Aggregate and anonymous data is information that does not identify you specifically, including data collected automatically when you enter our Site (“**Non-Personal Data**”). This may include cookies, pixel tags, web beacons, browser analysis tools and web server logs. Your data will be saved on Amazon's AWS European servers that comply with the ISO/IEC 27001 standard. We will use Amazon DynamoDB to save the textual information and images will be saved into an S3 instance. The information will be encrypted with the public-private key pair-based encryption on the user's computer and directly uploaded to Amazon in encrypted form. We will securely hold the private key and will be able to decrypt the information if requested from us by the authorities.

Unfortunately, no data transmission over Wi-Fi or the Internet or any processing of data via connected digital means can be 100% secure. Thus, we cannot guarantee or warrant the security of any information you disclose or transmit to us online.
